



### Where the Funds Were Spent



### One child. One place. One time.

This philosophy is at the core of all we do at Project Harmony. Every child deserves the opportunity to grow up safe, happy and healthy; and as adults we have no greater responsibility than the protection of our children against victimization, abuse and neglect. Abuse particularly if the victim is a child - steals their innocence, replacing it with fear and hurt that can damage young lives in a way that can take a lifetime from which to recover. Our services lead to healing for victims, including:

### **Forensic Interviews**

When requested by law enforcement or Child Protective Services, a child interview specialist will conduct a video-taped forensic interview with the child. One of the goals of this interview is to reduce the number of times the child must tell the story of his/her abuse. Reducing the number of interviews reduces the trauma of the child.

### **Medical Exams**

Our medical and nursing staff specializes in evaluating children who are suspected to have been abused or neglected. Their role is to provide physical abuse and sexual abuse assessments as well as comprehensive physical exams for children placed in foster care. In addition, our staff is able to provide expert medical opinion to referral agencies regarding suspected cases of child abuse and neglect.

### **Assessment and Referrals**

Mental health professionals assess each child's needs and refer them to the appropriate therapy, support groups and other resources.

Families also receive help in "understanding the system." Regular follow-up contact with the family assures a better case outcome.

### Multidisciplinary **Teams**

Multidisciplinary teams consisting of law enforcement, Child Protective Services, medical professionals, prosecution, school personnel, Project Harmony staff and other professionals regularly review cases to make certain children do not "fall through the cracks." Teams work


toward making changes and finding solutions to any problems in reporting and investigating child abuse, permanency, treatment and system issues.

### Child Victims of Abuse Are Counting On All Of Us

Through 2012, Project Harmony continued to offer Darkness to Light - Stewards of Children program. This is an evidence-based child sexual abuse prevention training program proven effective in educating adults to prevent, recognize, and react responsibly to child sexual abuse.

Project Harmony offers the Stewards of Children program to all adults that serve as caregivers to children. Most adults do not know how to recognize signs of sexual abuse and many do not know what to do when sexual abuse is discovered. Stewards of Children provides the training and information to these caregivers so that when abuse is either suspected or confirmed, individuals can take immediate yet informed action.

The stage set as a boxing ring with four chairs for a comfortable conversation between 3 panelists; Project Harmony Executive Director Gene Klein, WOWT Anchor John Knicely, Speaking of Children Presenter Bruce D. Perry, MD, PhD and Sugar Ray Leonard. It was the first time Sugar Ray publicly spoke of the sexual abuse he suffered as a 15 year-old Olympic boxing hopeful. In his visit to Project Harmony, the former Olympian and world champion boxer talked from personal experience of two sex abusers who stole his innocence as a child. He kept the secret hidden for decades, he said, trying to cope with the pain by retreating into alcohol and drug use. He recognized the years it took to erase the terrible memories of what was done to him by those adults.

Sugar Ray's heartfelt message acknowledged the benefits a child advocacy center plays with children and the resolve it would have brought had there been one for him.


