

#### From Our Executive Director

#### Dear Friends,

In 2017, Project Harmony served more than 5,000 children from the Omaha metro and southwest Iowa areas through early intervention and response services. Child abuse is a fact in our community, discriminating against no one and impacting thousands of lives each year. Because of Project Harmony's coordination of care between agencies such as departments of health and human services, law enforcement, Children's Hospital & Medical Center, Lutheran Family Services, Child Saving Institute, as well as many other partnerships — these children are able to go from crisis to courage.

It should come as no surprise, with tremendous growth experienced over the last 20+ years, we are not the same small agency we once were. However, it has been important for us (as an agency) to not lose sight of the traits that make us Project Harmony. Over the last year, we have worked together to define our culture and to ensure strategic planning and leadership are in line with the culture identified:

#### We Are All Project Harmony

Project Harmony exists because of a unique collaboration of community partners who are dedicated to ending child abuse and neglect. Our strength lies in our people, their ideas, their differences, and their diverse talents and perspectives.


#### We Bring Our Best Every Day

Project Harmony is comprised of experts, problem solvers and visionaries dedicated to promoting creativity and innovation. We are dedicated to fostering a learning environment, where all members of the collaborative process can flourish.

#### When It Comes to Children, We Don't Compromise

Children come first in all we do. Our vision reimagines the system to make it work best for all involved, especially the child.

As we look ahead, it is clear there will be continued growth and expansion. Not only will Project Harmony's reach increase, but so will the number of children who are able to use their voice without fear so healing can begin. Project Harmony has expanded our advocacy and mental health services to children and families impacted by child abuse and neglect. We offer on-site caregiver and child support groups (both in English and Spanish), provide accompaniment to court, and make connections to community resources and informal support networks.



Almost two years ago, Project Harmony took ownership of two buildings to the east of where Project Harmony currently resides. Renovation in the first building was completed in June of 2017. This new space allows us to focus specifically on mental health treatment where our teams can expand upon preventative care as well as respond to crisis situations.

The move of Connections and Lutheran Family Services to the new building has allowed for an expanded partnership with the Omaha Police Department. OPD's Domestic Violence Unit relocated to Project Harmony last June. Statistics show that 3.3 million children witness domestic violence in their homes each year. We anticipate more interviews, advocacy, medical exams and mental health services will occur for cases in which children are involved in domestic violence.

We have seen first-hand the progress that has been made in increasing awareness about abuse, but it has also illuminated that the need for prevention now is greater than ever. Over the past few months, we have seen a ripple effect of what happens when celebrities, athletes and government officials come forward in the media. Campaigns such as #MeToo are intended to open our eyes to what is happening around us (and the tendency of society to cover it up at the expense of children). These allegations, as they unfold, are the reality of families, communities and admired institutions everywhere — including the Omaha metro area. As more and more survivors courageously come forward, the need for response and preventative services is greater than ever, and Project Harmony appreciates your continued support and generosity to help us serve them in the most timely, sensitive and healing way possible.








#### **CHILDREN'S SERVICES FINDINGS**



#### **DEVELOPMENT/OPERATIONS**

Measuring Project Harmony's community impact is essential to understanding our progress toward ending the cycle of child abuse and neglect. With that in mind, Project Harmony implemented a **new client management system** in 2017, allowing us and our partners to collect more comprehensive data to inform and tailor our services moving forward. Our greatest resources are the staff members that bring their best to Project Harmony every day to help children and families navigate complex and difficult situations. In 2017, the Project Harmony Leadership Team created a **multifaceted professional development program** centered around a healthy culture that emphasizes collaboration and putting children first. 66 I am proud to work for this organization and believe that we are making a difference in the lives of children and families. 99

#### CHILDREN'S SERVICES

Midway through 2017, the Domestic Violence Unit of the Omaha Police Department moved into the Project Harmony building. They stepped up to be an active partner with us, and renewed their focus on the needs of child witnesses. We saw a dramatic impact as our number of **child witness interviews tripled** from the previous year to 293 interviews.

Project Harmony also obtained VOCA (Victims of Crime Act) funding in 2017 for **three additional advocates** (totaling six) to serve the increasing numbers of children and families we serve.

#### TRIAGE CENTER

Project Harmony partners with Child Saving Institute to provide a welcoming center for children in immediate need of alternative family placement. The Project Harmony Triage Center **comforted 422 children** (894 visits) in 2017, providing each with a light meal, clothing and other items as needed.

Eighty percent of Family Permanency Specialists **rated Triage Center services as either excellent or good** on the biannual Satisfaction Survey. #### CHILDREN'S SERVICES MENTAL HEALTH & ADVOCACY

Project Harmony **added four therapists** in 2017, enhancing our ability to serve more clients and extending our support to siblings, parents and caregivers. By focusing on the entire family, our therapists have the chance to communicate easily and coordinate treatment goals, allowing everyone to heal and move forward. 2017 brought on the **first caregiver support group** within Children's Services, focused on serving Spanish-speaking families. A partnership and collaboration with Completely KIDS, the organization focused on families who have experienced sexual abuse, and saw great success — serving 28 families in our community.

#### Project Harmony relaunched NebraskaMentalHealth.com in 2017.

NebraskaMentalHealth.com provides centralized access to local and regional mental health information in a single location. The goal of the site is to expand knowledge about mental health terminology and help connect those in need with those who can help. All Nebraska providers are encouraged to visit the site and create a profile – connecting with those looking for care.

#### **CONNECTIONS**

We reshaped the Connections program in 2017 to better address the needs of the community. In turn, Connections added 23 Omaha Public Schools and opened services to all Bellevue elementary and middle schools. The program **now serves four major school districts** in the Omaha metro area.

Connections also created a specialty workgroup with the goal of **better serving the immigrant and refugee populations**. Building strong partnerships with other organizations doing similar work in the Omaha community, the workgroup delivered many outcomes in 2017, including the creation of a four-part training series for providers of immigrants and refugees.

Early in the development of the Connections program, we realized to keep up with referrals, we needed to find ways to serve children in groups. With that in mind, Connections **expanded its group offerings in 2017** to include expressive arts therapy and CBITS (Cognitive Behavioral Intervention for Trauma in Schools), both serving to better help kids cope with traumatic events.

#### CASE COORDINATION

In 2017, Project Harmony's partner agencies PromiseShip and the Nebraska Department of Health and Human Services **instituted a policy** where all expectant mothers with open Child Protective Services cases will be staffed at our Impact from Infancy Team. Case professionals have found these staffings to be helpful, preventing removals by having an agreed upon action plan. Project Harmony also combined the Non-Court and the Douglas County Treatment teams, resulting in two treatment teams specializing in medically fragile and developmentally disabled children and youth missing from care. Part of a collaboration with the Juvenile Assessment Center, Douglas County Attorney's Office and Omaha Police Department, Project Harmony **helps track missing youth** and ensures that our response is coordinated across systems. **SS** Everyone was kind and patient with making sure that I understood what was going on and provided information for additional services. **99** - Project Harmony Client

#### TRAINING

Project Harmony trained 3,026 people in trauma and trauma-informed care as part of the **Trauma Matters Omaha** initiative over the course of 2017. Area elementary and middle schools have shown a great interest in this topic, leading to trauma trainings in 24 schools. The training team **took collaboration to new heights in 2017**. We worked with Creighton University's nursing program to train 116 nursing students in empathy and partnered with 64 professionals — in a variety of fields such as law enforcement, advocacy, substance abuse treatment, juvenile court law, domestic violence and child welfare to help enhance our training offerings with new perspectives. During 2017 alone, we were able to spend 563 hours training 10,036 participants.
