### **Letter From Our Executive Director**

### Dear Friends,

As we look back and celebrate 25 years, our work has been able to expand and evolve thanks to you!

We are incredibly grateful for the impact you have made on Project Harmony and the lives you have influenced. Your support and generosity have fueled our growth over the past 25 years and set the stage for the next 25+ years. Imagine with us the possibility of ending child abuse and neglect.

Project Harmony is dedicated to the goal of breaking the cycle of child abuse and neglect. Our innovative approach brings together multiple agencies on one campus, allowing for effective coordination and support for the most vulnerable among us. As Henry Ford wisely said, "Coming together is a beginning; keeping together is progress; working together is success."

I want to personally thank Henry Davis for his unwavering support and his constant encouragement to dream bigger, seek greater, look deeper, and reach farther. Henry Davis was honored at our recent 25th Anniversary celebration because of his incredible support and leadership through the years. Child abuse and neglect was intensified during the COVID-19 pandemic. Additionally, the increase in children's online activities has exposed them to technology-facilitated violence, sexual exploitation, and abuse. Last year alone, over 6,000 children sought help at Project Harmony, and your support allows them to find hope and healing. The impact extends to their caregivers as well, as their healing journey is crucial for a child's progress.

What I find really encouraging is that in addition to the 6,000+ children and families served through our response services, an additional 2,000 were served in a PROACTIVE and PREVENTATIVE effort through our Connections program. Connections works with 147 elementary and middle schools to provide support to children and families in need of mental health care when those children have been struggling with life's challenges. The pandemic forced us to be creative with technology, and our staff embraced platforms like Zoom and TEAMS to connect and collaborate effectively. Our training team capitalized on this opportunity and last year filled over 23,000 seats on-line and in person- representing individuals from 42 states and 15 countries. An amazing accomplishment and testament to the reach of this impactful training on best practices and skill development for those working with children and families. Furthermore, we welcomed Homeland Security on our campus, working alongside the Omaha Police Department and our Missing Youth Services and Anti-Trafficking Team. Their presence allows for greater resources in protecting vulnerable children who are abused on-line or being trafficked across state lines. In 2022, the Anti-Trafficking Program assisted 31 juveniles in its first year, while Project Harmony served a total of 140 missing youths. We aim to serve even more in the coming year.

Within these pages, we showcase our collaborative and innovative approach to helping children and engaging families, made possible by the continued support of our generous donors and supporters.

On behalf of the 8,065 children served in 2022, who may not be able to express their gratitude directly, please accept this letter as their heartfelt thanks to you.




### Total Children Served +24.4% from 2021




### Intakes of Type of Abuse

## **The Heartbeat of Our Mission**

In 2022, we conducted a cultural assessment, implemented a new HRIS platform, created an Employee Engagement Committee and a DEI Committee, and offered leadership development and compensation analysis. These initiatives helped us improve employee satisfaction, retention, performance, and diversity.

### Project Harmony recently underwent an organization wide, strategic planning session.

During this session, we established four major areas of focus, with one notably being "Building a Great Culture." The primary objectives within this initiative included the formation and reinforcement of DEI initiatives across the organization, the creation of an Employee Engagement Committee to concentrate on the employee journey, the continuous emphasis on growth and development for all employees, and the expansion of communication channels. These efforts have greatly fortified our commitment to building an outstanding culture. Some significant achievements were the review and revision of our cultural values and value statements, revamping our milestone/work anniversary celebrations, and the creation of a new DEI committee and Employee Engagement Committee, along with monthly Executive Roundtable Luncheons for work anniversaries.

Starting in 2021 and continuing through 2022, we initiated an organizational-wide cultural assessment. This comprehensive evaluation revealed a lot about our evolving workforce and its ever changing needs. It became clear that each department was unique and diverse, necessitating a personalized approach towards an employee-centric workforce. Some positive outcomes of this assessment's first phase were increased flexibility across departments, a stronger focus on workload and emotional strain management, the launch of a leadership development pathway to equip leaders with extra tools for success, and the instigation of a compensation analysis to ensure equitable pay across the agency.

The cultural assessment, while ongoing, has already yielded successful results, such as pay equity adjustments, an expansion of headcount in various program areas following a data-driven analysis, and improved retention rates. In fact, turnover rates decreased significantly from 2021 to 2022.

Lastly, we implemented a new HRIS to offer a unified platform for employees, covering everything from recruitment to onboarding and their ongoing journey. This platform enhances transparency around benefits, pay, and community involvement. It also enables the organization to quickly gather data for generating workforce reports, aiding the HR team in identifying potential themes and opportunities to consider.



### PROJECT HARMONY TRAINING INSTITUTE

## **Guiding Growth**

In 2022, the Project Harmony Training Institute experienced an extraordinary level of participation, with over **23,000 attendees** from **42 states** and **15 countries** enrolled in our diverse training sessions. This accounts for a 9% increase from the previous year. These sessions ranged from face-to-face meetings, to instructor-led virtual sessions, and fully asynchronous trainings.

### We designed and introduced several innovative training programs including...

#### Online Safety for Parents, Guardians and the Community:

Developed from materials provided by the National Center for Missing and Exploited Children, this training equips participants with the skills necessary to initiate ongoing, age-appropriate discussions about online safety with the children in their lives.

#### Building Hope in Yourself and Others:

As hope is the primary predictor of future well-being and resilience in the face of trauma, this training is crucial. Participants learn to define, measure, and cultivate hope in their own lives and inspire hope in others. In 2022, we extended this training to Educational Services Units throughout the state, introducing them to the application of hope science in schools. Over 1,500 people were trained in the first year, and we plan to launch the Hope Champions Network in 2023, engaging various professionals across our community sectors.

# **United We Thrive**

One of the enduring objectives of the Connections program is to alleviate the stigma associated with seeking mental health treatment. As discussions about mental wellness become increasingly prevalent, the program is consistently exploring innovative and exciting methods to foster mental wellbeing, particularly in children.

### **Collaborative Partnerships**

To ensure mental health services are genuinely accessible, it is crucial to offer them in environments where children and families feel most at ease. Recognizing this, Connections has fostered strong ties with Omaha area school districts. We have expanded our scope to provide both individual and group therapy within the Learning Community Centers of North and South Omaha.





### **Expressive Arts**

Connections was honored to receive a grant from the Omaha West Rotary Club, which facilitated an innovative group experience that involved an entire classroom – students and their teacher alike.

In collaboration with Betsy Funk, LCSW LIMHP MPA REAT of the Omaha Therapy and Arts Collaborative, we offered an Expressive Arts Therapy Group. This program's primary objective was to provide a shared platform for a classroom community, enabling them to understand and explore various expressive outlets, including visual arts, movement, dramatic play, or music. By engaging in these creative expressions, participants could develop essential coping mechanisms and emotional regulation skills. A key differentiating factor of this group therapy session was its inclusion of the teacher. By actively participating in the sessions, teachers received the same supportive instruction as their students, fostering a shared understanding and reinforcing their role in the learning journey.

Upon the program's conclusion, the class collaborated on a communal art project, creating a unique piece that showcased their individual and collective identities, and the transformative power of shared therapeutic experiences.

The expressive arts groups were important to our 1st-grade students because the group helped them identify new ways to communicate how they feel. ### We are delighted to welcome our new facility dog, Warrior!



His gentle and affectionate nature has already begun to shine through, endearing him to everyone at the facility.

"We've already seen a huge difference in just how excited the children are to meet either Woody or Warrior," said Project Harmony Director of Communications Angela Roeber. "Children come in anxious and scared and as soon as they meet one of our furry colleagues, they relax. There is something about petting a dog that is so calming and therapeutic. The more you pet Woody or Warrior the more they comfort you and it really makes that child, who is going through a terrible situation, feel better."

Woody and Warrior help kids feel safe and comfortable as they describe the abuse they have experienced or crime they have witnessed. The dogs calm their fears and bring smiles to faces that have not smiled in a long time. One of Woody and Warrior's most valued qualities is the unconditional love and attention they give to the children with whom they interact.

# **Nurturing Resilience**

Olivia is a brave child who was sexually abused and was struggling to disclose her trauma. Project Harmony helped her find her voice and begin a path toward healing through a coordinated and collaborative response involving multiple agencies and professionals.

#### We welcomed Olivia to Project Harmony following a report

made to the Department of Health and Human Services (DHHS) and Law Enforcement, expressing concerns of potential sexual abuse. Initially, Olivia was hesitant during her forensic interview, a space created to allow her to discuss her experiences. However, with our Facility Dog Warrior providing comfort and support, she gradually began to share what happened to her.

As Olivia shared some details, it became apparent that her sister, Emma, might also need to be interviewed. Emma's additional information corroborated Olivia's initial disclosure. While Olivia's testimony was sparse, it hinted at more disturbing circumstances at home that she was not yet prepared to discuss further. Project Harmony arranged a medical examination for Olivia to provide reassurance and a chance to address any questions she might have with a medical professional. Given the case's complexities, a Multi-Disciplinary Team (MDT) review was suggested.

We convened an MDT composed of professionals from across the metro area, each bringing years of child welfare experience to the table. Together, they developed a support plan for the sisters, designed to encourage further disclosure about their home situation. The team identified a therapy regimen that utilized evidence-based practices to help the sisters, creating a safe and comforting environment for them to process their experiences. As Olivia engaged with therapy, she began to reveal more details about her abuse.

The therapist's extensive training and knowledge of child welfare led to a second forensic interview, where comforted by the presence of Warrior, Olivia was able to disclose more. Despite sharing additional details about her abuse, she remained guarded about the full extent of what had happened.

Following the interview, Olivia continued her therapy sessions and gradually disclosed more information, necessitating a third interview. On each visit to Project Harmony for a forensic interview, Olivia was offered a medical consultation. While there are more revelations to come, Olivia shared to the extent of her comfort, indicating her willingness to return when ready to divulge more. Her trust in our team and her faith in the process to help her reclaim her voice are testimonies to her resilience.

This narrative underlines the collaborative and coordinated response that paved the way for a child to narrate her experience of abuse, culminating in holding the offender accountable. It is a testament to how therapy can enable a child to find their voice, and how skilled therapists can respond when a child is empowered to share. At Project Harmony, we were able to provide a safe and comforting environment for Olivia, always prepared to listen whenever she is ready to share more.

Her trust in our team and her faith in the process to help her reclaim her voice are testimonies to her resilience.



### MISSING YOUTH SERVICES / ANTI-TRAFFICKING

# **Breaking Chains**

Melissa was rescued from a dangerous sex trafficking situation after disclosing information during a forensic interview at Project Harmony. Project Harmony collaborated with building partners and community partners to provide Melissa with safety, stability, and treatment.

### Melissa's journey with Project Harmony's Anti-Trafficking Program

began when concerns of sexual abuse led DHHS to bring her in for a forensic interview. During the course of this interview, Melissa revealed that she might be a victim of trafficking by an unreported individual. Immediately, Law Enforcement sprang into action, successfully extracting Melissa from the potentially dangerous situation. Harmony ATYS Therapist. The ATYS Therapist can go into the community and meet youth where they are, helping to alleviate barriers such as transportation and trust. Boys Town permitted Melissa's therapist to continue therapy sessions during her stay as to maintain consistency throughout treatment.

While at Boys Town, Melissa also maintained regular contact with Law Enforcement and Project Harmony's

The information Melissa disclosed during the forensic interview, coupled with Law Enforcement's insights, necessitated the assembly of a Multi-Disciplinary Team (MDT). Comprised of all professionals involved in Melissa's case, this team's mandate was to chart out Melissa's next steps.

Boys Town, a close ally of Project Harmony's Anti-Trafficking Program, reserves two beds in their Intervention and Assessment (I&A) Shelter specifically for our Anti-Trafficking Youth Services (ATYS) children. The MDT concluded that one of these spots would be the optimal placement for Melissa, and an advocate from the Anti-Trafficking Program was promptly assigned to her case.

Melissa's dangerous trafficking situation had led to severe



ATYS Specialist. This consistent interaction helped foster a relationship of trust and supported the ongoing investigation.

A month after Melissa's extraction from the lifethreatening trafficking situation, her trafficker was apprehended. Melissa was now in a stable placement, receiving the treatment she needed. The ATYS program, including the ATYS Specialist, ATYS Mental Health Therapist, and Law Enforcement, have continued to stay in touch with Melissa, understanding the time needed to heal from such a traumatic experience. Despite setbacks and struggles, the team continues to support her as she embarks on her long road to recovery.

Melissa's story illustrates the power of collaboration between building partners,

addiction to multiple substances. Placement at Boys Town provided a secure environment for her to safely detox while a long-term plan was being formulated by her team of professionals.

During her time at Boys Town, Melissa received a mental health assessment and started therapy with a Project

including Children's Services staff, ATYS Specialists and Therapists, MDT Coordinators, and Law Enforcement, as well as our partnership with Boys Town.

For youth entangled in dangerous and life-threatening situations, this partnership helps forge clear a path to positive outcomes.


# Igniting Change

Firefighters say children are responsible for about \$300 Million in damage and nearly 300 deaths by fire every year in the United States. By partnering with the Omaha Fire Department, we're working to intervene and educate to prevent future fire setters. The Youth Fire Intervention program provides assessment, counseling, referral services, fire safety education, followup services, and case management to youth who have been involved in fire setting behavior. The program also helps prevent property damage, injuries, deaths, legal consequences, and emotional trauma caused by youthset fires.

In 2022, our collaboration with Fire Apparatus Engineer Mike Davenport of the Omaha Fire Department, a former Kids First Award winner and valued partner of Project Harmony, led to a significant breakthrough. Confronted with a scarcity of mental health therapists adept in working with youth with a history of fire setting, Mike turned to the Project Harmony Training Institute. Our strategic alliances allowed us to enlist the expertise of a national authority, Dr. Robert Stadolnik. His training sessions with local therapists and Project Harmony staff in Omaha focused on best practices for assessing and planning care for children with these unique challenges.




# Sustaining the Mission
